The above transfers are subject to the following conditions:

- The maximum number of chances to be provided for male GDS is two and three for female GDS. This may be ensured before issue of Transfer order.
- The GDS will rank junior in the seniority list of the new unit/division to all the GDS of that Unit /division who exist in the seniority list on the date on which the transfer is ordered, except in case of transfer within the same engagement / recruitment sub Division/ Unit/Division.
- Transfer will be at the cost and expenditure of the GDS concerned. NO expenditure whatsoever on this account will be borne by the Department under any circumstances.



- iv. The GDS will not have any claim to go back to the previous engagement / recruitment unit / division at any circumstances.
- v. The relief of the GDS may be done by the Divisional Heads after confirming that no Disciplinary case or Vigilance case is pending or contemplated against the GDS and also ensure whether verification formalities viz Caste, Education and Police verification report etc. have been completed.
- vi. A written undertaking from his / her agreeing the conditions may be obtained and kept on record.
- vii. Please ensure whether Level TRCA slab is same according to instructions contained in Sl.No.1 (x) of the Directorate letter dated 15.7.2021
