

Sub: Change in the date of Holiday on account of Muharram.

Ref: DoPT OM in F.No.12/13/2016-JCA-2 dated 11/08/2021.

The Department of Personnel & Training vide its OM in F.No.12/13/2016-JCA-2 dated 11/08/2021 has changed the date of holiday to be observed on account of Muharram from 19/08/2021 to 20/08/2021 in the state of Delhi/New Delhi. For offices outside Delhi/New Delhi, the Central Government Employees Welfare Co-ordination Committee can decide the date depending on the decision of the concerned State Government.

2. Government of Karnataka vide order dated 21/11/2020 has declared holiday for Muharram on 20/08/2021.

3. In view of the above, the holiday on account of Muharram will be observed on 20/08/2021 (Friday) in place of 19/08/2021 as previously announced by CGEWCC, Bengaluru on 04/12/2020.
