In continuation of CO Notification No.R&E/1-12/LGO/2020 dated 09.11.2020 communicated vide this office letter No.BGR/R&E/LGO/PM/MG/MTS dated 11.11.2020, the examination for recruitment to the cadre of Postal Assistant/Sorting Assistant amongst Postman/Mail Guard/Despatch Rider and Multi Tasking Staff (MTS) in Postal Divisions /Units, RMS, MMS for the vacancy year 2020 (01.01.2020 to 31.12.2020) was held on 20.12.2020.

2.In accordance with the Directorate instructions contained in letter No.17-08/2018-SPB-I dated 10.05.2019, as amended vide letters of even no. dated 10.06.2019, 20.06.2019, 28.06.2019, 11.07.2019, 23.07.2019 and 11.12.2019, the Data Entry Skill Test (DEST) was conducted for qualified candidates in Paper-I and Paper-II on 28.02.2021.

3.In accordance with the Directorate instructions contained in letter No. 17-08/2018-SPB-I dated 10.05.2019, the candidates who qualify in Paper-I, Paper-II and Paper-III separately shall be considered for final selection and their **Merit shall be drawn in order of marks secured in Paper-I since both Paper-II and Paper-III (DEST) are qualifying in nature. The result has been compiled taking the scores of Paper-I as merit.**

4.The Division wise information containing names of successful candidates (arranged in the order of division wise merit) is shown in **Annexure-I**. In respect of candidates of a particular division who scored equal marks, their inter-se seniority is fixed as per the rules on the subject. Consequent to this, if there is change in the merit list, the same may be communicated to this office for issuing correction. The results will be uploaded in the Departmental website and [www.karnatakapost.gov.in](http://www.karnatakapost.gov.in) by CO.

5. The information relating to names of the candidates, their roll numbers and categories have been shown on the basis of information furnished by the Heads of Division and units. ***In case there are any mistakes in the details of candidate(s), the same may be intimated to this office for necessary action. In case, it is found subsequently that any of the selected candidate(s) was not eligible to take the examination under the existing rules/instructions on the subject or for any reasons or in case any mistake is found with regard to announcement of results of any candidate for any reason whatsoever his/her name will be deleted from the list of successful candidates, as the case may be.***

6. It may be ensured that ***no provisional candidate is given appointment without regularization of their candidature.*** The Divisions are requested to verify the current status of the candidature of the qualified candidates before promoting the official. The official/candidate against whom vigilance or disciplinary case is pending/those undergoing punishment should not be promoted and such cases should be referred back to this office.

7. In case, if it is found subsequently that any of the promoted / selected candidate(s) was not eligible to take the examination under the existing rules/instructions on the subject or for any reasons or in the case any mistake is found with regard to announcement of results of any candidate for any reason whatsoever his/her name will be deleted from the list of successful candidates, as the case may be. This result is also subject to any change in the merit list of successful candidate's due to any unforeseen reason in accordance with the existing rules and instructions on the subject or orders of Hon'ble CAT / High Court, if any."

8. The category of candidates may be re-checked with reference to the Government of Karnataka order No.SWD 713 SAD 93 dated 11-03-2002 communicated vide CO letter No.STA/26-1/5/Rlgs/VII/PT dated 22-05-2003.

**9. The provision of reviewing of results of failed SC/ST candidates has been revisited by the Postal Service Board & decided to discontinue, as communicated vide Postal Directorate letter No.4-13.2015-SPB-I dated 08.04.2016.**

10. Since the examination has been conducted using OMR answer sheets, the request for re-totalling /re-valuation will not be entertained. Photo copies of answer papers will be supplied to the candidates on submission of application under RTI Act. Applications under RTI Act for supply of photo copies of answer papers will be entertained.
