The Postmasters General, N K Region / S K Region /BG HQ Region are requested to issue necessary allotment/posting orders immediately. On receipt of posting orders, the officials may please be relieved immediately by the Divisional Heads to join in his/her promotional post unless they submit unconditional declination. The Regional/Divisional heads of the Regions/present divisions will personally ensure issue of posting orders and immediate relief of the officials.

Promotion ordered herein are subject to the following conditions :

1. Official drawing his / her pay in Level-7 in the pay matrix of 7th CPC is not eligible for any fixation under the provisions of FR-22(1) (a) (1). If the official is not drawing the pay in the levels of pay matrix referred to above may exercise his / her option for pay fixation under the provisions of FR-22 (1) (a) (1) within one month from the date of assumption of charge in the promoted post. There shall, however, be no further fixation of pay at the time of regular promotion if it is in the same grade pay as granted under MACPS.
2. **In case of any vigilance / disciplinary case pending or contemplated / currency of punishment against any official, he/she should not be relieved on promotion and the fact should be reported to this office at once.**
3. The officials should accept the promotion within one month from the date mentioned in "Remarks" column. In case the official declines promotion, a letter declining the promotion unconditionally may please be obtained and forwarded to this office for its acceptance by the Competent Authority.
4. If the official declines promotion, he/she should note that they are not eligible for promotion to the cadre of HSG-I for a period of (1) one year either on regular or adhoc basis from the date of declination. Further the officials who decline promotion will not be considered for financial upgradation under MACP scheme, if any due, as per the existing rules/instructions till they accept promotion.
5. Divisional Superintendents concerned may please be instructed to relieve the officials immediately on issue of posting orders so as to enable the officials to join the promotional post within the stipulated time.
6. Regional Heads/Divisional Heads shall invariably forward a copy of the Promotion order issued to Circle Office.
7. The category of the officials belonging to SC/ST community may be verified and it may also be ensured that Schedule Caste / Tribe of the officials are still figuring in the notified central list of SC/ST before actually giving them promotion. A certificate having undertaken such a verification may be intimated to this office.
8. The promotion will remain subject to the outcome of SLP © No. 30621/2011 (Jarnail Singh & Ors Vs Lachhmi Narain Gupta & Ors) and SLP © No. 31288/2017 and any other court cases in connected matter, as conveyed vide Directorate letter no. 137-15/2014-SPN-II dated 19.03.2019.
