Based on the results of Combined Higher Secondary Level Examination 2018 declared by Staff Selection Commission, your name has been sponsored for appointment as Postal Assistant/Sorting Assistant in Department of Posts, in Level 4 of the Pay matrix. Subsequently, the Director General, Department of Posts, New Delhi 110001 has allotted you to Karnataka Postal Circle as per your merit and preference of Circle for taking further action for completion of other procedural requirements.

2. A candidate will be allotted to any one cadre amongst the following three (3) cadres only subject to availability of vacancy (Annexure-I) in the cadre under their category:

SL. No.	Name of the cadre	Cadre Code
1	Postal Assistants in Post Offices	PA(PO)
2	Sorting Assistants in Railway Mail Service	SA (RMS)
3	Postal Assistants in Circle Office and Regional Offices	PA(CO/RO)

Note : Cadre once allotted will be final and is not interchangeable / transferrable afterwards.

3. Important notes for candidates:

(a) **Postal Assistants (PO) cadre posts and Sorting Assistants (SA) cadre posts** are Divisional level posts located in offices covering the respective Postal/RMS divisional jurisdiction.

(b) **Postal Assistants (CO/RO) posts** in Karnataka are available in Circle Office located in Bengaluru, Bengaluru HQ Regional office located in Bengaluru and South Karnataka Regional office located in Bengaluru and North Karnataka Regional office located at



Dharwad and transferable among these offices in the Circle. However, posting of selected candidates will be **subject to Administrative exigencies and availability of vacancies in each office on merit.**

(c) **The candidate should submit his/her option/ preference form as per Annexure-II. The submission of preference is mandatory.**

4. (a) A candidate shall be allocated the cadre and division/unit/office on the basis of her/his merit(rank), order of preference(option) and vacancy available at her/his turn in the category she/he has been selected.

(b) **SC/ST/OBC candidates selected against UR vacancies, if any will be allotted against vacancies available under UR category only.**

(c) **The candidates selected against the quota for Persons with Disabilities (PWD) and Ex-serviceman will be placed in the appropriate category viz. (SC/ST/OBC/General) depending upon the category to which they belong.**

5. (a) All the selected candidates who are allotted to Karnataka Postal Circle are requested to indicate their preference of cadre in the applicable option form in the space provided at 'A'. ***The order of preference once submitted to this office cannot be changed.***

Note: A candidate should indicate her/his option/order of preference for all cadres, if applicable.


(b) Further, candidates are also requested to indicate their preference of divisions in the selected cadres in the option letter in the space provided at 'B'.

Note: 1. A Candidate should indicate her/his option/order of preference for all divisions /units (where vacancies are available for the category against which selected) in all the cadres. *The order of preference once submitted to this office cannot be changed.*

2. The candidates selected against PwD and Ex-Serviceman quota should submit the option / preference to the divisions where vacancies are earmarked to that quota only. Preference exercised for any other division/unit will be treated as invalid.

6. (a) Person with Disability (PWD) candidate irrespective of the ranks will be allocated cadre and division/unit/office first followed by Ex-Serviceman candidates as per the vacancy available in the category.

(b) After allocation of cadres and divisions/unit/office to PWD candidates and Ex Serviceman candidates, remaining candidates will be allocated cadres and divisions/units/office in the manner mentioned at para 4 above.



(c) The SC/ST/OBC candidates selected against UR vacancies i.e **selected under category 9**, if any, will be posted against vacancies available under UR category only. The candidates will be posted against the category selected (shown by the Postal Directorate).

(d) Such candidates who are not able to get allocation in any of the post of her/his preference because of her/his preference might be allocated to the post/division where the vacancies exist at the discretion of the Competent Authority.

(e) All such candidates who do not give any order of preference shall be allocated to cadres and divisions subject to availability of vacancy in the category she/he has been selected after allocation of posts to all other candidates (who have given preferences) **at the discretion of the competent authority which will be final.**

7. (a) The duly filled in and signed option form must be sent either by **Speed Post/Registered Post only** and scanned copy of option form by e-mail to email Id karssc2018@gmail.com so as to reach this office **on or before 21-02-2022** failing which it would be presumed that she/he has no preferences for cadre/divisions and will be allotted as per para 6 (e).





Subject: Allocation of Postal Circle for appointment as Postal Assistant / Sorting Assistant on the basis of Combined Higher Secondary Level Examination, 2018 conducted by SSC.

Madam/Sir,

I am directed to state that Staff Selection Commission (SSC) has nominated 3673 candidates on the basis of final results of Combined Higher Secondary Level Examination, 2018. Dossier(s) of 120 out of 122 candidates allocated to your Circle, as detailed in Annexure, are forwarded for appointment as Postal Assistant / Sorting Assistant against the vacancies for the year 2018 and for being retained as part of the personal file(s) of the candidate(s) concerned.

2. Although SSC has recommended 3673 candidates for appointment as Postal Assistant / Sorting Assistant on the basis of CHSL Examination, 2018; SSC has confirmed nomination of 3652 candidates and their dossiers have been received till date. All 3673 candidates have been allocated to Postal Circles irrespective of the status of receipt of their dossiers in Department of Posts. Circle may initiate the process for issuing offer of appointment to the nominated candidates. All those candidates whose dossiers are yet to be forwarded by the SSC, their candidature shall be subject to confirmation of nomination / forwarding of dossiers by SSC and till such time they shall have no claim over the appointment to the said posts in the Department of Posts. **Consequently, in case of candidates whose nominations are yet to be confirmed / dossiers are yet to be forwarded by SSC, the appointing authority shall not issue offer of appointment to these candidates till confirmation of nomination by SSC and receipt of dossiers by Department of Posts.**

36011/1/2012-Estt.(Res.) dated 14.03.2016. It is also requested that following documents/particulars of the candidate(s) may be checked thoroughly at the time of joining:-

- (i) Date of Birth.
- (ii) Essential Qualification as on the crucial date.
- (iii) Age relaxation claimed by the candidate(s), if any.
- (iv) SC/ST/OBC/EWS/ESM/PwD Certificate issued by the Competent Authority.
- (v) In respect of OBC candidate(s), the extant guidelines regarding creamy layer status may be followed strictly.
- (vi) The genuineness of OBC certificate indicating Non-creamy layer status issued by the prescribed authorities need to be verified in case of OBC candidate(s) who have been selected on provisional basis.
- (vii) The eligibility of the candidate(s) whose candidature has been kept provisional for reasons other than OBC status should be verified.
- (viii) Candidate's result, rank, category etc. may be verified with the result available on the Commission's website and the list enclosed.
- (ix) Photograph, signature, LTI and Handwriting taken on Admission Certificate (Commission's copy) and documents obtained at different stages of examination need to be verified with those the candidate(s) may actually submit at the time of joining he service.
- (x) Photograph of the candidate captured at the time of Computer Based Examination (all Tiers/Stages), Skill Test (if applicable) and Document Verification have been provided in the candidate's dossier. These photographs may be matched with each other as well as with the candidate who is offered the appointment.
- (xi) In case of any suspicion in the candidature of the candidate, the same may be referred to the Commission immediately. In case, the offer of appointment has already been issued then the case may be referred to the appropriate authorities like Central Forensic Science Laboratory (CFSL).

5. In addition, pre-appointment formalities such as Character and Antecedent Verification & Medical Examination etc. of the candidate(s) may also be completed as per extant Rules and Regulations of the Government.

6. Offer of appointment to the candidate(s) should be sent only by Registered Post and issued at the earliest possible so that they do not have to wait for unduly long period and also the vacancies in question are filled expeditiously. If the letters are returned undelivered, the letter alongwith the envelopes containing remarks made by the postal authorities should be retained for record. In such cases, a copy of the offer of appointment should be sent to the permanent address and email id of the candidates. The dossiers of such candidates should be returned to the concerned regional Office of the SSC only if the second letter/mail is also undelivered/ unanswered respectively. In case where offer of appointment is cancelled by the Circle, full facts thereof should be intimated to this office as well as to the regional Office of SSC. Copy of the individual offer of appointment, when issued, may be enclosed to the concerned regional Office of the SSC.

7. In cases where offer of appointment has been sent to the candidate(s) and candidate(s) has sought extension of time of joining the post, the same may be considered with the guidelines contained in DOPT OM No. 9/23/71-Estt.(D) dated 06.06.1978 and OM No. 35015/2/93-Estt.(D)

dated 09.08.1985. Further, after completion of the appointment process a consolidated report *inter alia* including the names of candidates appointed, number of candidates refused to join and number of candidates who do not respond to offer of appointment may also be sent to Directorate.

8. In case of any doubt or suspicion as regards to the eligibility or otherwise in respect of any of the recommended candidate, the Circle may write to the SSC even after his/her appointment, giving details for getting such case(s) investigated through appropriate Government Agency.
