Memo No. R&E/1-12/LGO/2020 dated at Bengaluru 560001 the 24-03-2021

Sub: Allotment of Surplus qualified candidates in respect of the limited Competitive Departmental Examination (LDCE) from LGOs for promotion to the cadre of Postal Assistant/Sorting Assistant from Postman/Mail Guard and MTS in Postal Divisions/Units, RMS, MMS for vacancy year 2020 held on 20-12-2020 (Sunday)

This is in continuation of the following:

- (i) The Postmaster General Bengaluru (HQ) Region, Bengaluru-560001 memo no. BGR/R&E/LDCE/GDS/2020-21 dated 04-03-2021.
- (ii) The Postmaster General, North Karnataka Region, Dharwad-580001 memo no. NKR/STA-1/211/2020/II dated 04-03-2021.
- (iii) The Postmaster General, South Karnataka Region, Bengaluru-560001 memo no. SK/R&E/1-12/LGO-GDS/2020/CON dated 04-03-2021.

The list of surplus qualified candidates who are selected for promotion to the cadre of Postal Assistant/Sorting Assistant on merit, to the extent of vacancies is shown in **Annexure-I**. The surplus result has been compiled taking the scores of candidates in Paper-I as merit. As there are no vacancies of PA/SA cadre in the concerned Division/unit where the candidates are presently working, the competent Authority has allotted them to other Divisions where the vacancies remained unfilled, after going through their places of preference to the extent of available vacancies. These candidates will not be considered for transfer under Rule 38 before completion of required service in the allotted Division. These candidates will not be repatriated to his/her parent division/unit even to his/her substantive post in the lower grade so long as he/she continues in the clerical cadre in the new division/unit. Their representations, if any received to that effect will not be entertained in Circle Office and therefore they should be disposed off at Divisional/Regional level itself.

2. In respect of candidates of a particular Division who scored equal marks, their inter-se seniority is fixed as per the rules on the subject. Consequent to this, if there is change in the merit list, the same may be communicated to this office for issuing correction. The result is also available in the Departmental website and www.karnatakapost.gov.in.

3. The information relating to names of the candidates, their roll numbers and categories have been shown on the basis of information furnished by the Heads of Region/Divisional office and units. In case there are any mistakes in the details of candidate(s), the same may be intimated to this office for necessary action. In case, if it is found subsequently that any of the selected candidate(s) was not eligible to take the examination under the existing rules/instructions on the subject or for any reasons or in case any mistake is found with regard to announcement of results of any candidate for any reason whatsoever his/her name will be deleted from the list of Surplus candidates, as the case may be.

4. It may be ensured that no provisional candidate is given appointment without regularization of the their candidature. The Divisions/Regions are requested to verify the current status of the candidature of the qualified candidates before promoting the official. The official/candidate against whom vigilance or disciplinary case is pending/those undergoing punishment should not be promoted and such cases should be referred back to this office.

5. The provision of reviewing of results of failed SC/ST candidates has been revisited by the Postal Service Board & decided to discontinue, as communicated vide Postal Directorate letter no. 4-13.2015-SPB-I dated 08.04.2016.

6. Since the examination has been conducted using OMR answer sheets, the request for re-totaling/revaluation will not be entertained. Photo copies of answer papers will be supplied to the candidates on submission of application under RTI Act.

a) Candidates, who wish to have the copies of OMR answer Sheets supplied are required to pay a fee of Rs.25/- per paper plus Rs.10/- towards fee for application under RTI Act in the post office and submit their applications through the Division/Unit concerned authenticating Roll no. of the candidate (through proper channel only) along with the receipt for payment of fee in original.

b) The period of preservation of OMR answer paper is one year from the date of declaration of this result. Therefore applications received after one year for supply of photo copies of answer paper will not be entertained.


c) Photo copies of answer paper will be supplied only to the candidates who appeared for the examination. Therefore the candidates should invariably intimate their Roll Number in the application under RTI Act.

7. Please note that the results are declared based on the preferences given by the candidates/officials. In case any surplus selected candidate declines promotion, the next candidate in merit list will be considered for promotion. No redraw of merit list of surplus qualified candidates will be done. No representation from already selected candidates will be considered. No changes will be made in the results already declared.

The results and the contents of this memo may be brought to the notice of all concerned.
