Subject : Merger of Postmaster Cadre with General line cadre- fixation of seniority & circulation draft circle seniority lists.

Postmaster cadres (PM Gr-I, II & III) have since been merged with General line cadre (LSG, HSG-II & HSG-I) vide Dte. Letter No. 25-19/2018-PE-I dtd 10-07-2019. Guidelines on merger of Postmaster Cadre with General Line cadre are issued in Dte. Letter No. X-1-3/2019-SPN-II dated 26-07-2019. Copies of the said letters are enclosed.

The seniority of the officials is refixed in accordance with Dte. orders on the subject as under:


1. To maintain uniformity, the date of publication of results/date of issue of promotion order have been taken as date of promotion in all cadres i.e. LSG, HSG-II & HSG-I, PM Gr-I , PM Gr-II & PM Gr-III , for fixation of seniority.
2. Seniority of PM Gr-III officials are refixed with respect to their inter se seniority in HSG-II level in accordance with Dte. Letter No. 1-5/2015-SPB-II dtd 21-02-2019 (copy enclosed), before merger with HSG-I cadre.
3. Some officials declined their promotion hence their seniority has to be fixed as per their date of promotion.
4. Date of notional promotion for the eligible officials is indicated in the remarks col. However **antedating of such promotion on Notional basis shall be for the purpose of seniority only and shall have no effect on pay and the official will continue to draw pay on the basis of their actual date of promotion,** as per Dte. letter dtd 26-07-2019.

Draft merged Circle seniority lists of HSG-I & PM Gr-III, HSG-II & PM Gr-II, LSG & PM Gr-I are enclosed. The same may please be circulated to all concerned including those who are on leave, under aquittance & advise them to submit representations if any, within 15 days.

It is also requested ;

- i. To verify the service particulars of officials working in your division/unit & to report discrepancies/correction/deletion/additions if any, with documentary evidences, immediately.
- ii. To forward the representations, if any, received from the officials, to this office with comments & supporting documents.
- iii. To furnish the Educational qualification, present pay & designation of the officials to incorporate the same in the CGL.

The acquittance obtained from the officials may be kept on record and a certificate for having circulated the said draft circle seniority lists should be sent to this office by 15-10-2019.
