**Sub: Declaration of Results of the Limited Departmental Examination (LDCE) for recruitment to the cadre of Postal Assistant/Sorting Assistant amongst Postman/Mail Guard/Dispatch Rider and Multi-Tasking Staff (MTS) in Postal Divisions/Units, RMS, MMS for the vacancy year 2019 (01-01-2019 to 31-12-2019) held on 15-09-2019 (Sunday).**

In continuation of this office notification no. R&E/1-12/LGO/2019 dated 05-08-2019, the examination for recruitment to the cadre of Postal Assistant/Sorting Assistant amongst Postman/Mail Guard/Dispatch Rider and Multi-Tasking Staff (MTS) in Postal Divisions/Units, RMS, MMS for the vacancy year 2019 (01-01-2019 to 31-12-2019) was held on 15-09-2019.

2. In accordance with the Directorate instructions contained in Letter No. 17-08/2018-SPB-I dated 10-05-2019, as amended vide letters of even No. dated 10-06-2019, 20-06-2019, 28-06-2019, 11-07-2019, 23-07-2019 and 11-12-2019, the Data Entry Skilled Test (DEST) and was conducted on 09-02-2020 for qualified candidates in Paper-I and Paper-II held on 15-09-2019.

3. In accordance with the Directorate instructions contained in Letter No Letter No. 17-08/2018-SPB-I dated 10-05-2019, the candidates who qualify in Paper-I, Paper-II and Paper-III separately shall be considered for final selection and their Merit shall be drawn in order of marks secured in Paper-I since both Paper-II and Paper-III (DEST) are qualifying in nature. The result has been compiled taking the scores of Paper-I as merit.

4. The Division wise information containing Names of successful candidates (arranged in the order of division wise merit) is shown in **Annexure-I**. In respect of candidates of a particular Division who scored equal marks, their inter-se seniority is fixed as per the rules on the subject. Consequent to this, if there is change in the merit list, the same may be communicated to this office for issuing correction. The result is also available in the Departmental website and [www.karnatakapost.gov.in](http://www.karnatakapost.gov.in).

5. The information relating to names of the candidates, their roll numbers and categories have been shown on the basis of information furnished by the Heads of Region/Divisional office and units. In case there are any mistakes in the details of candidate(s), the same may be intimated to this office for necessary action. In case, if it is found subsequently that any of the selected candidate(s) was not eligible to take the examination under the existing rules/instructions on the subject or for any reasons or in case any mistake is found with regard to announcement of results of any candidate for any reason whatsoever his/her name will be deleted from the list of successful candidates, as the case may be.

6. It may be **ensured that no provisional candidate is given appointment without regularization of the their candidature.** The Divisions/Regions are requested to verify the current status of the candidature of the qualified candidates before promoting the official. The official/candidate against whom vigilance or disciplinary case is pending/those undergoing punishment should not be promoted and such cases should be referred back to this office.

7. **The provision of reviewing of results of failed SC/ST candidates has been revisited by the Postal Service Board & decided to discontinue, as communicated vide Postal Directorate letter no. 4-13.2015-SPB-I dated 08.04.2016.**

8. Since the examination has been conducted using OMR answer sheets, the request for re-totaling/revaluation will not be entertained. Photo copies of answer papers will be supplied to the candidates on submission of application under RTI Act. Applications under RTI Act for supply of photo copies of answer papers will be entertained.

a) **Candidates, who wish to have the copies of OMR answer Sheets supplied are required to pay a fee of Rs.25/- per paper with key plus Rs.10/- towards fee for application under RTI Act in the post office** and submit their applications through the Division/Unit concerned (through proper channel only) along with the receipt for payment of fee in original.

b) The period of preservation of OMR answer paper is one year from the date of declaration of this result. Therefore applications received after one year for supply of photo copies of answer paper will not be entertained.

- c) Photo copies of answer paper will be supplied only to the candidates who appeared for the examination. Therefore the candidates should invariably intimate their Roll Number in the application under RTI Act.
