Sub: Results of the Examination for promotion of LGOs to the cadre of PAs/SAs for the year 2017-18 held on 09-12-2018.

The examination for promotion of LGOs to the cadre of PAs/SAs for the year 2016-17, 2017-18 & 2018 was held on Sunday, the 9th December 2018. Now the Competent Authority has ordered for declaration of the results for the year 2017-18. This is in continuation to this office memo of even no. dated 27-05-2019.

2. The provisional keys and final answer keys were displayed in the departmental website by the Directorate. The Directorate in letter No.F-No.A-34012/05/2018-DE dated 22nd February 2019 has specified the qualifying marks paper wise is as under:

3. The Division wise information containing Names of successful candidates (arranged in the order of division wise merit) is shown in **Annexure-I**. In respect of candidates of a particular Division who scored equal marks, their inter-se seniority is fixed as per the rules on the subject. Consequent to this, if there is change in the merit list, the same may be communicated to this office for issuing correction. The result is also available in the Departmental website (www.karnatakapost.gov.in).

4. The information relating to names of the candidates, their roll numbers and categories have been shown on the basis of information furnished by the Heads of Region/Divisional office and units. In case there are any mistakes in the details of candidate(s), the same may be intimated to this office for necessary action. In case, if it is found subsequently that any of the selected candidate(s) was not eligible to take the examination under the existing rules/instructions on the subject or for any reasons or in case any mistake is found with regard to announcement of results of any candidate for any reason whatsoever his/her name will be deleted from the list of successful candidates, as the case may be.

5. It may be **ensured that no provisional candidate is given appointment without regularization of the their candidature**. The Divisions/Regions are requested to verify the current status of the candidature of the qualified candidates before promoting the official. The official/candidate against whom vigilance or disciplinary case is pending/those undergoing punishment should not be promoted and such cases should be referred back to this office.

6. The details of Division wise unfilled vacancies are shown in **Annexure-III**. **The Heads of Regions/Divisions/Units may take immediate action to call for the preference from surplus qualified candidates of their Division shown in the combined merit list (Annexure-II) & the same be sent to this office within (7) seven days without fail in the enclosed Annexure-IV(Declaration)**. As far as possible, the candidates will be accommodated according to the preference given by them. In the event of an official in the merit list of surplus passed candidates is not willing to accept promotion in another division, the post will be offered to next candidate in the list. It may be brought to the notice of such candidates that **option once given is final and no withdrawal or change is allowed subsequently**. Action will be initiated against such candidates as the entire exercise will become futile. Orders for filling up of unfilled vacancies, which are not filled in some divisions due to non availability of sufficient number of qualified candidates, will be issued by this office after receipt of options from the surplus qualified candidates through proper channel. **Allotment of surplus candidates will be purely on merit basis to the extent of vacancies available.**

7. The provision of reviewing of results of failed SC/ST candidates has been revisited by the Postal Service Board & decided to discontinue, as communicated vide Postal Directorate letter no. 4-13.2015-SPB-I dated 08.04.2016.

8. Since the examination has been conducted using OMR answer sheets, the request for re-totaling/revaluation will not be entertained. Photo copies of answer papers will be supplied to the candidates on submission of application under RTI Act. Applications under RTI Act for supply of photo copies of answer papers will be entertained in the following manner.

9. Final Key answers {A, B, C & D series} of the above said exam are already uploaded in the Indiapost website- www.indiapost.gov.in. This information need not be sought under RTI.


- a) **Candidates, who wish to have the copies of OMR answer Sheets supplied are required to pay a fee of Rs.25/- per paper with key plus Rs.10/- towards fee for application under RTI Act in the post office** and submit their applications through the Division/Unit concerned (through proper channel only) along with the receipt for payment of fee in original. In turn, the Regional office(s) will prepare a consolidated list in the Second week of June 2019 i.e latest by 15.06-2019. The Heads of Regions/Divisions/Units should also send a copy of the list by e-mail to rectt.ka@indiapost.gov.in.
- b) The period of preservation of OMR answer paper is one year from the date of declaration of this result. Therefore applications received after one year for supply of photo copies of answer paper will not be entertained.
- c) Photo copies of answer paper will be supplied only to the candidates who appeared for the examination. **Therefore the candidates should invariably intimate their Roll Number in the application under RTI Act.**
