**Sub: Allotment of Surplus qualified candidates in respect of the limited Competitive Departmental Examination (LDCE) for LGOs for promotion to the cadre of PA/SA from Postman/Mail Guard and MTs cadre held on 09.12.2018 vacancies for the year 2016-17, 2017-18 & 2018 (01.04.2018 to 31.12.2018).**

The list of surplus qualified candidates in LGOs examination held on 09.12.2018 for promotion as Postal Assistant/Sorting Assistant and allotted to Divisions as per their requests are enclosed herewith for the year 2016-17, 2017-18 and 2018 in "Annexure-I, Annexure-II & Annexure-III" for further necessary action. As there are no vacancies of PA/SA cadre in the concerned Division/unit where the candidate is presently working, the competent Authority has allotted them to other Divisions for re-allotting the surplus qualified candidates to his parent division of any other division where vacancies arise subsequently. Their representations, if any received to that effect will not be entertained in Circle Office and therefore they should be disposed off at Divisional/Regional level itself. These cases will not be considered under Rule 38 before completion of two (2) years of service in the Division to which they are allotted now. The candidate will not be repatriated to his parent division/unit even to his/her substantive post in the lower grade so long as he/she continues in the clerical cadre in the new division/unit.

2 The names of the candidates are arranged strictly in the order of merit in the division/ unit concerned. They will rank junior to those who were already declared successful in the LGO examination held on 09.12.2018, vacancies for the particular year i.e. 2016-17, 2017-18 and 2018.

3 The details of disciplinary/vigilance cases pending/contemplated if any against the official in the list should be furnished along-with Xerox copies of the relevant documents. The details of Court cases/CAT cases if any filed by the Department against the official of filed by the officials against the Department should also be furnished. Please also confirm whether any of the candidates were permitted provisionally for said examination.

4 The result is subject to the conditions that if it is later found that any of the candidates selected is not eligible to take examination under the existing rule/instructions on the subject or for any reasons of in case, any mistake is later found with regard to announcement of the result of any of candidate for any reasons whatsoever, his name will be deleted from the list of successful candidates.

5 The results are also subject to any change in the merit list of the selected candidates due to future re-totalling and verification of answer sheets in accordance with the existing rules on the subject.

6 It may be ensured that no provisional candidate is given appointment without regularization of the candidature. The Divisions/Regions are requested to verify the current status of the candidature of the qualified candidates before promoting the official. The

officials/ candidates against whom vigilance or disciplinary case is pending/ those undergoing punishment should not be promoted and such cases should be referred to this office.

7 The community of the candidates should be checked up by the Divisional Heads concerned before taking further action.

8 The Division/Unit Heads may ensure to cause timely issuance of appointment letters so that the officials can join in their respective offices of posting at the earliest i.e. not later than 28.06.2019. The guidelines issued vide Directorate letter no. 60-11/2011-SPB.I dated 16.09.2011 may be taken into consideration while issuing appointment order.

9 The candidates have been allotted based on their preference and in order of merit to the extent of vacancies.
