In continuation of this office memo of even number dated 19-08-2022, approval of the Competent Authority is hereby conveyed for release of provisional selection list to the cadre of Postman against 5% Direct Recruitment reserved for meritorious sports persons under sports quota as per the notification issued vide this office letter No. R&E/1-23/Sports/2019 dated 17-01-2020 to the cadre of Postman.

3. **Method of Selection adopted by the selection committee nominated by Chief Postmaster General:** selection of meritorious sports persons has been made on the basis of proof of sports qualification and educational qualifications provided by the candidates and in accordance with the instructions contained in Ministry of Personnel, Public Grievances and Pensions, Department of Personnel & Training Office Memorandum No.14034/01/2013-Estt(D) dated 03-10-2013 as amended from time to time, further circulated vide Postal Directorate vide endorsement No 14-01/2013-PAP dated 14-10-2013, Ministry of Home Affairs, Department of Personnel and Administrative Reforms, vide Office Memorandum No 14015/1/78-Estt (D) dated 28th November 1981, read with OM No.14015/1/76-Estt.(D) dated a Aug.1980 and instructions/clarification issued by Postal Directorate vide letter no 17-07/2017-5PN-ldated 06.01.2021. **First Preference** has been accorded to candidates who have represented the country in an INTERNATIONAL competition and on the basis of verified FORM-I.



Note:- Selection in respect of remaining vacancies of 14 Postman posts (International achievements - FORM-I) have been kept in sealed cover / withheld for want of clarification from Directorate.

5. As per Department of Posts Postman and Mail Guard (Group -C post) Recruitment Rules, 2018, the candidate shall also possess the following for appointment as Postman.

- 12th standard pass from a recognized Board.
- Knowledge of local (Kannada) language and the candidate should have studied Kannada language upto 10th standard.
- Knowledge of working on computer.

Note 1: The person appointed to the post of Postman shall acquire a driving license to drive two wheeler or three wheeler or light motor vehicle within a period of two years from the date of his appointment. However, persons with disability shall be exempted from the requirement of driving license.

Note 2: A candidate not having valid driving license at the time of appointment shall not earn periodical increment in pay till production of such license or for a period of five years from the date of appointment whichever is earlier and after production of such license or expiry of such five years period, pay shall be restored prospectively to the level pay would have reached had the periodical increment in pay was not withheld and no arrears of pay shall be paid for the intervening period.

6. The respective Divisional / Unit Head should take further action to issue offer of appointment / formal appointment orders only on 16-05-2023 observing usual formalities including verification of educational certificates, caste certificates collection of pre-appointment papers etc to be done as per the Directorate instructions from time to time. Applications along with the copies of the certificates in respect of the candidates are enclosed herewith for taking further necessary action at your end for appointment of the candidates.

7. As per the instruction of DoPT OM No. 18011/2(s)/2016-Estt(B)(i) dated 29.06.2016 and OM No. 36011/1/2012-Estt.(Res) dated 14.03.2016, action has to be taken for appointment of candidates allotted to your divisions/units. The call letter/offer of appointment has to be issued to the selected candidates by Registered Post with acknowledgment due and to email id of the candidates, if available, without fail only **on 16-05-2023**. If the letters are returned undelivered, the letter along with the envelopes containing remarks made by the postal authorities should be retained for record. After following the prescribed procedure, the offer of appointment has to be cancelled by the appointing authority and cancellation order has to be issued and full facts of the case may be intimated to Circle Office. The application of such candidates should be returned to Circle Office along with the copy of offer of appointment, subsequent reminder and memo of cancellation of candidature, only if the second letter /e-mail is also undelivered/unanswered.

8. While issuing provisional offer of appointment on 16-05-2023, the candidate may be asked to produce the originals of educational certificates and other documents such as caste certificate, certificate of date of birth etc. on the day of reporting/joining.

9. It is directed that the following Original documents/particulars of the candidate(s) may be checked thoroughly at the time of issue of provisional appointment order / joining, with reference to the eligibility conditions notified vide this office vide Notification No. R&E/1-23/Sports/2019 dated 17-01-2020:

- a) Certificate regarding Date of Birth
- b) Certificate relating to Educational qualification and Computer Knowledge

- c) SC/ST/OBC/EWS certificates, if any, issued by the competent authority in prescribed format approved by the Government of India
- d) In respect of OBC candidate, the extant guidelines regarding creamy layer status be strictly followed. 3
- e) Age relaxation for various categories under Sports Quota recruitment, as mentioned below, may be allowed on production of necessary certificates. Age – 18 to 27 years as on 16-03-2020(Age relaxation for SC/ST/PH- Ten years, OBC- Eight years, UR-Five years)
- f) Valid Photo ID proof.
- g) Photograph, Signature in the applications need to be verified with those the candidate(s) may actually submit at the time of joining the service.

10. In addition, pre-appointment formalities such as Character and Antecedent Verification & Medical Examination etc. of the candidate(s) may also be completed as per the extant Rules and Regulations of the Government. The Appointing Authority has to get the documents verified from the issuing authorities. However, the appointment shall not be kept on hold on the ground that any such document appears to be suspicious. The offer of appointment as well as the provisional appointment order shall clearly specify that, if any information or document submitted by the candidate is found to be incorrect at a later stage, which would have rendered him ineligible for appointment under Sports Quota recruitment, he/she shall be terminated from the service.

11. All the candidates allotted to Postman cadre under Sports Quota have been selected based on the Form-I certificate (for representing Country in an International Competition) submitted by the candidates along with the application. Form-I certificate submitted by the candidate have already been verified with the concerned authority in respect of the candidates selected provisionally and whose results have been published.

12. However, the genuineness of the certificates/documents supporting the eligibility of the candidates, all conditions prescribed in the notification issued vide this office Ir. No. R&E/1-23/Sports/2019 dated 17-01-2020 and instructions issued by the Department has to be checked by the appointing authority.

13. The selection of candidates is based on the following terms and conditions:-

- a. The candidature of all candidates is provisional and selection is subject to fulfillment of all conditions prescribed above and as per relevant Recruitment Rules.
- b. The DOPT OM No. 18011/2(s)/216-Estt. (B)(i) dated 29.06.2016 which inter alia provides that the offer of appointment need not be withheld pending verification of character and antecedents.




- c. As per the DOPT instructions vide letter **No. 36011/1/2012-Estt.(Res) dated 14.03.2016**, Where a selected candidate belongs to SC/ST/OBC category, is unable to produce a SC/ST/OBC certificate from any of the prescribed authorities, he/she may be appointed provisionally on the basis of whatever prima-facie proof he/she is able to produce in support of his/her claim, subject to his/her furnishing the prescribed certificate within a reasonable time.
- d. The merit list of the candidates is provisional and subject to completion of formalities like verification of all records, Medical examination from Competent Medical Officer and other verifications prescribed in the rules.
- e. If it is later found that any of these candidates was not eligible for recruitment under Sports Quota under the rules or instructions on the subject or other reasons or in case any mistake is later found with regard to announcement of the results of any candidate for any reason whatsoever, his/her name will be deleted from the list of successful candidates, as the case may be. The result is also subject to any change in merit list of selected candidates for any reason in accordance with the existing rules and instructions on the subject.
- f. As per Directorate's Ir. No. 1-12/98/WL/Sports dated 10th March 1999 para no. 3(B) sub para 2(iii), the recruited Sportspersons should be adjusted against the category(SC/ST/OBC/EWS/UR) to which he/she belongs.

14. Allotment of candidates:-

- a) The candidates have been allotted to Divisions/Units based on the preference of division/unit submitted by the candidates, availability of vacancies on their turn and fulfillment of all the conditions prescribed.
- b) In case of candidates who had not submitted the order of preferences, it is presumed that he/she has equal preference for all the Divisions/units and such candidates have been allotted to Divisions/units where vacancies existed and subject to fulfillment of all the conditions prescribed.

15. The selection is also subject to any change in merit list of the selected candidate due to any unforeseen reason in accordance with the extant rules on the subject. The present result is further subject to outcome of court/CAT cases, correction of clerical mistake if any. The candidature of selected candidate is liable to be cancelled if later on it is found that the false information has been given by the candidate or the candidate was not eligible due to any criminal case against him/her otherwise. The selection has been recommended on the basis of information furnished by the candidate.

16. The selection of candidates is purely provisional subject to fulfillment of required conditions of relevant recruitment rules and verification of genuineness of various mandatory certificates of the candidates from the issuing authorities and Department of Sports, Ministry of Youth Affairs and Sports.

17. Their seniority may be fixed in the respective Divisions/units according to existing rules.


18. No further Supplementary list/ wait list will be maintained / published in respect of this notification. Any vacancy remaining unfilled including sealed cover cases, due to non-reporting of candidates or documents not found correct or for any other reason, shall be added to the overall vacancy of next vacancy year for making recruitment as per the provisions of the Recruitment Rules of the respective Post.

19. In case of any doubt or suspicion as regards to the eligibility or otherwise in respect of any of the recommended candidate, the Division/Unit may write to Staff Section, Circle Office (through concerned region) even after his/her appointment giving details for taking up such case(s) investigated through appropriate Government Agency.
